THIS DEED, made this the 24th. day of October, 1973 by, and between Robert H. Wakefield, and wife Margurite Wakefield, of Rowan County, George H. Pritchett and wife Roberta W. Pritchett, of Alamance County, Mildred Pearl Sapp, Forsythe County, Thomas R. McCollum and wife Kathleen W. McCollum, and Clyde S. Pleasants and his wife Carrie W. Pleasants of Guilford County, and State of North Carolina hereinafter called grantors, and Harold F. Dunévant, of Forsyth County and State of North Carolina, hereinafter called Grantee.

WITNESSETH: That the Grantors, for and in consideration of the sum of Ten Dollars and other good and valuable considerations to them in hand paid by the Grantee, the receipt whereof is hereby acknowledged, have given, granted, bargained, sold and conveyed, and by these presents does give, grant, bargain, sell, convey and confirm unto the Grantee, his heirs and or successors and assigns, the premises in Winston Township, Forsyth County, North Carolina, described as follows:

Lot No. 11 in Block No. 2 as shown on P.H. Hanes Map of West Highlands, recorded in Plat Book 2, Page 46 A (3) in the Office of the Register of Deeds of Forsyth County, North Carolina, to which reference is hereby made for a more particular description.

Together with all heating, plumbing and lighting fixtures and equipment now attached to or used in connection with the said real estate.

The above land was inherited by the Grantors under the Will of Ellen Wakefield, Forsyth County, Winston Salem, North Carolina. TO HAVE AND TO HOLD the above described premises, with all the appurtenances thereunto belonging, or any wise appertaining, unto the grantee, his heirs and or successors and assigns forever. And the Grantors covenants that they are seized of said premises in fee, and have the right to convey the same in fee simple; that said premises are free from encumbrances (with the exceptions above stated, if any); and that they will warrant and defend the said title to the same against the lawful claims of all persons whomsoever.

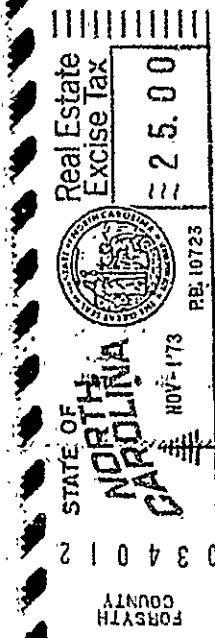

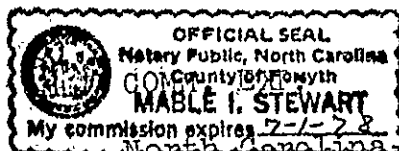

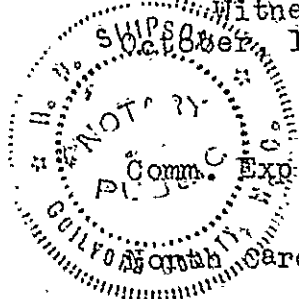
