

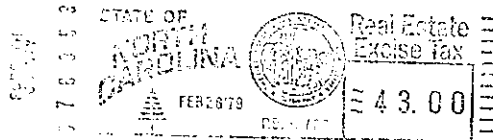

Witnesseth that the said part ies of the first part, in consideration of (\$ 10.00 o.v.c.) Ten dollars and
other Valuable Consideration to be paid by the said part ies of the second
part, the receipt of which is hereby acknowledged, has/have bargained and sold, and by these presents do bargain, sell and convey
unto the said part ies of the second part and their heirs a tract or parcel of land in Forsyth County, North Carolina, in
Southfork Township, and bounded as follows:

BEGINNING at an iron stake, said iron stake being the Southwestern corner of Lot No. 12 as shown on the Map of Lakewood Estates recorded in Plat Book 16, at page 137, in the Office of the Register of Deeds of Forsyth County, North Carolina; running thence along the Western boundary of Lot No. 12 and the Eastern boundary of a 20 foot dedicated drive North 01 degrees 54' East 249.94 feet to an iron stake, being the Northwest corner of Lot No. 12; thence South 83 degrees 47' East 100.11 feet along the Northern boundary of Lot No. 12 to an iron stake; thence South 00 degrees 11' West 109.91 feet to an iron stake; thence South 03 degrees 38' West 140.64 feet to an iron stake in the right of way line on the North side of Lake Drive; thence North 83 degrees 28' West 99.60 feet along the right of way line on the North side of Lake Drive to the point and place of Beginning; same being the Western portion of Lot No. 12 as shown on the Map of Lakewood Estates, recorded in Plat Book 16, at page 137, in the Forsyth County Registry.
