Hauser in Deed Book 781 at page 438 in said center line; from said beginning point thus established, thence, running North 2° 45' 19" East 32.81 feet to an iron stake; thence, continuing North 2° 45' 19" East 151.45 feet to an iron stake, said latter iron stake being located South 74° 12' 31" East 10 feet from an iron in the line of Billy C. Speas (see Book 1171 at page 260 of the Forsyth County Registry); thence, running with a line of William H. Hauser South 74° 12' 31" East 185.54 feet to an iron stake in the said Hauser line; thence, running South 18° 23' 20" West 176.22 feet to an iron stake and continuing South 18° 23' 20" West 30.20 feet to a point in the center line of the aforementioned Boiling Springs Road; thence, running with said center line of Boiling Springs Road North 65° 08' 30" West 68.19 feet to a point and continuing North 60° 52' 18" West 69.15 feet to the point and place of Beginning. The same containing .71 acres, more or less, according to the hereinafter referred to survey.
