Witnesseth That the said parties of the first part, in consideration of (\$10.00 o.v.c.) Ten Dollars and  
other valuable considerations to them paid by the said part y of the second  
part, the receipt of which is hereby acknowledged, has/have bargained and sold, and by these presents do

bargain, sell and convey unto the said part y of the second part and his heirs a tract or parcel of  
land in the County of Forsyth and State of North Carolina, in Salem Chapel Township, and bounded as follows:

BEGINNING at an iron stake in the Western right of way line of Pine Hall Road, the Northeast corner of the within described tract and the Southeast corner of Dewey A. Bowman et ux (Deed Book 866, page 222); and running thence along the Western right of way line of Pine Hall Road, the following courses and distances: South 36° 35' West 1000 feet; South 32° 59' West 100 feet; South 29° 29' West 100 feet; South 25° 45' West 100 feet; South 22° 56' West 100 feet; South 17° 37' West 100 feet; South 13° 8' West 100 feet; South 10° 55' West 622.08 feet to an iron stake; thence North 83° 10' 38" West 952.62 feet to an iron stake; thence North 30° 52' East 114.5 feet to an iron stake; thence North 82° 13' West 2,019.85 feet to an iron stake in the centerline of a creek; thence North 13° 04' East 360.45 feet, Zura Miles corner (Block 5167, Lot 10M); thence North 72° 38' West 89.67 feet to an iron stake; thence along the centerline of Lick Creek, a random line, the following courses and distances: North 8° 58' East 232.4 feet to an iron stake; North 18° 51' East 152.5 feet to an iron stake; North 52° 47' West 179.2 feet to an iron stake; North 18° 37' East 127.4 feet to an iron stake; North 20° 09' West 224.2 feet to a stake; North 43° 09' West 310.6 feet; North 16° 13' West 276 feet; North 16° 3' West 617 feet; North 3° 53' East 279 feet; North 23° 09' West 486.83 feet; thence leaving the creek South 81° 10' East 3041.5 feet to an old iron stake; thence South 8° 42' 23" West 864.84 feet, Mabe's corner; thence with Mabe's Southern line South 83° 04' 40" East 1695.45 feet to the point and place of BEGINNING, containing 214.15 acres, more or less, as shown on the survey of Joseph Parks Bennett, dated October, 1978, and being known as Block 5167, Lots 20, 21, 22 and 23 of the Forsyth County Tax Supervisors Office.




