

EXHIBIT A

BEGINNING at an existing iron stake in the southern right-of-way line of Myer-Lee Road, said iron stake being located in the point of intersection of the common corner of that property described in Book 888 at Page 126 of the Forsyth County Registry and that property described in Book 1352 at Page 739 of the Forsyth County Registry and said right-of-way line, said iron stake also being located the following two courses and distances from a concrete monument located at the southeast intersection of Myer Lee Road and Linville Road: South 47 degrees 22' 35" West 428.34 feet and South 46 degrees 54' 00" West 412.57 feet running along the southern right-of-way line of the said Myer Lee Road; thence from the said point of beginning North 89 degrees 56' 35" West 87.66 feet to an existing iron stake located in the northern right-of-way of Myer Lee Road thence continuing on the same course 89 degrees 56' 35" West 39.37 feet to an existing iron stake; thence North 50 degrees 50' 27" West 433.02 feet to a point in the centerline of the Southern Railway right-of-way (100 feet right-of way), thence with the centerline of said railroad right-of-way North 63 degrees 33' 17" East 292.79 feet to a point; thence South 42 degrees 23' 48" East 432.09 feet to an iron stake in the southern right-of-way line of Myer Lee Road; thence South 46 degrees 54' 00" West 124.21 feet along the southern right-of-way line of Myer Lee to the point and place of beginning. Containing 2.530 acres, more or less, and being a part of that property described in Book 1280 at Page 283, in the office of the Register of Deeds of Forsyth County, North Carolina. Said description is in accordance with a survey made by Joyce Engineering & Mapping Co., Inc. dated December, 1981, revised February, 1982.
