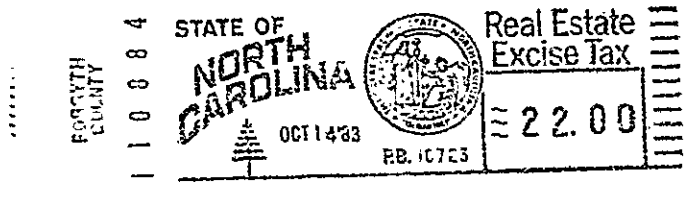
THIS DEED Made this the 12 day of September, 1983 by Clive J. Warren and wife, Anne Warren
