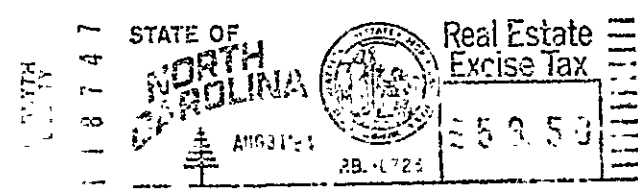
WITNESSETH:
