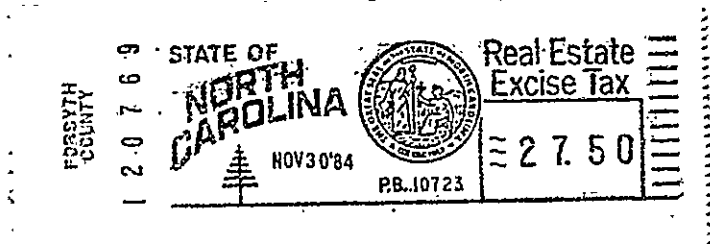
THIS DEED Made this the 24th day of November, 19 84 by Paula S. Lanier, (single)
