THIS DEED Made this the 8th day of August, 19 85 by George L. Jones and wife Wilma R. Jones

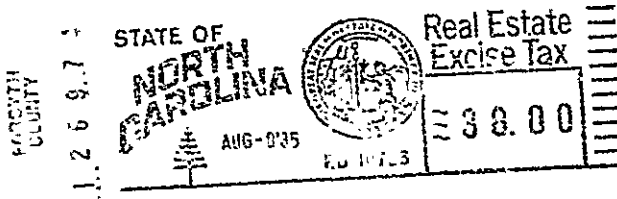

part, the receipt of which is hereby acknowledged, ~~has~~ have bargained and sold, and by these presents do not bargain, sell and convey unto the said part Y of the second part and her heirs a tract or parcel of land in Forsyth County, North Carolina, in Winston Township, and bounded as follows:

BEGINNING at a point 60 feet north of the southwest corner of Lot No. 57 and running thence northwardly 60 feet; thence eastwardly 208.9 feet to Carolina Boulevard; thence southwardly with Carolina Boulevard 60 feet to an iron stake; thence westwardly 208.9 feet to the place of beginning.
