That said party of the first part, in consideration of One Hundred Dollars (\$100.00) and other valuable considerations, to it paid by the parties of the second part, the receipt of which is hereby acknowledged, has bargained and sold and by these presents does bargain, sell and convey unto the said parties of the second part and their heirs and assigns, a certain tract or parcel of land located in Winston Township, Forsyth County, State of North Carolina, and bounded as follows:

BEING KNOWN AND DESIGNATED as Lot 98, as shown on the Map of Northills, Phase V, recorded in Plat Book 24 at page 184 in the Office of the Register of Deeds of Forsyth County, North Carolina, reference to which is hereby made for a more particular description.

TO HAVE AND TO HOLD the aforesaid tract, parcel or lot of land, all privileges and appurtenances thereto belonging to the said part iesof the second part and their heirs and assigns, to their only use and behoof forever;

AND THE SAID party of the first part covenants to and with the said part iesof the second part and their heirs and assigns, that it is seized of said premises in fee, and has the right to convey the same in fee simple; that the same are free from all encumbrances, and that it will warrant and defend the title to the same against the claims of all persons whatsoever, EXCEPT easements, rights of way and restrictive covenants of record, and ad valorem taxes for the fiscal year in which this deed of conveyance is given, if any, which taxes have been prorated to the date of this conveyance.
