Graves corner, in center of old road-way; thence with old road-way North 3 degrees 15' East 204 feet to iron stake in center of old road-way; thence with old road-way North 1 degree 14' East 186.7 feet to an iron stake in Old Belews Creek Road; thence with old road-way North 63 degrees West 160 feet to a point in old road-way, corner of Lot No. 8; thence with line of Lot No. 8 South 5 degrees West 430 feet to an iron stake, Coldwell's corner; thence with Coldwell's line South 35 degrees 8' East 45 feet to an iron stake, Coldwell and E. D. Graves corner; thence with E. D. Graves line South 54 degrees 45' East 145 feet to the beginning.
