NORTH CAROLINA GENERAL WARRANTY DEED

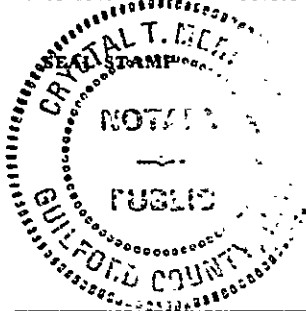
