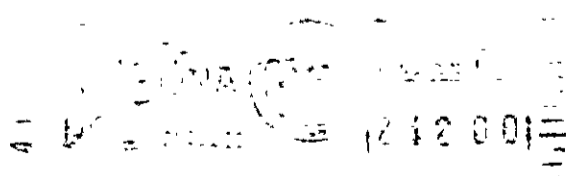
SEE EXHIBIT "A" ATTACHED HERETO AND INCORPORATED HEREIN AS IF FULLY SET FORTH.

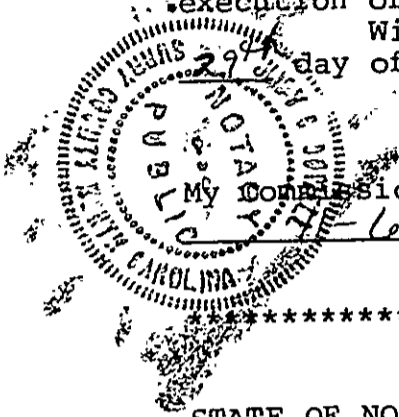

EXHIBIT "A"

BEGINNING at an iron stake in the northern right of way line of Valley View Road (formerly Old U. S. Highway 421), said point being located at the southeast corner of that property conveyed to Hervey D. Martin and husband Steve A. Martin as recorded in Book 1291, Page 1228, Forsyth County Registry, (as also described in Book 1305, Page 168) and running thence from said point of BEGINNING, North 1° 25' 00" East 80.3 feet to a point; thence North 00° 30' West 599 feet to a point marked by an iron at the southwest corner of that property conveyed to Minro Corporation as described in Book 1191, Page 1740, Forsyth County Registry; thence with the southern line of Minro Corporation, South 50° 22' East 390.3 feet to a point at the southeast corner of Minro Corporation as described above; thence South 5° 15' East 417.2 feet to an iron located in the northern right of way line of Valley View Road; thence running with the northern right of way line of Valley View Road, on a slight curve to the left, a chord course and distance of South 88° 17' West 123.4 feet to a point; thence continuing with said right of way, South 86° 18' West 223.5 feet to the point and place of Beginning, containing 4.05 acres, more or less.
