## FORSYTH COUNTY, NORTH CAROLINA GENERAL WARRANTY DEED

THIS DEED made this 28th day of September, 19 89, by and between

The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.

WITNESSETH, that the Grantor, in consideration of (\$10.00 & ovc) Ten Dollars and other valuable considerations paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land in Forsyth County, North Carolina Winston Township, more particularly described as follows:

BEGINNING at an iron stake on the north side of Nicholson Street (now 22nd Street), said stake being 175 feet east from the northeast intersection of Hood Street (now Cleveland Avenue) and Nicholson Street (now 22nd Street); thence East along the north side of Nicholson Street (now 22nd Street) 50 feet to an iron stake, and of that same width extending back North between parallel lines 150 feet to the south side of a 10 foot alley, the above-described property being Lot 143 as shown on map of Home Real Estate Loan and Insurance Company Hege Property as recorded in Deed Book 97, pages 588-589 in the Office of the Register of Deeds of Forsyth County, North Carolina.

The above land was conveyed to Grantor by D. Elwood Clinard, Jr. (see book number 1668 page 2254)


