THIS DEED, made and entered into this 5th day of October, 1989,
by and between Douglas P. Dettor, acting as Commissioner as hereinafter
stated, of Guilford County, North Carolina, party of the first part; and
William Crews/of Forsyth County, North Carolina, party of the second part;
and wife, Belinda Harden Crews,

WITNESSETH:

THAT WHEREAS, in a certain Special Proceeding entitled Elizabeth
F. Gorrell, Petitioner, vs. Linda F. Jones, Respondent (88-SP-369),
brought and pending before the Clerk of Superior Court of Guilford County,
North Carolina, an Order was made by said Court appointing said party of
the first part Commissioner to sell at private sale, subject to confirmation
of the Court, certain lands, including the land hereinafter described; and

WHEREAS, said party of the first part, acting as Commissioner as
aforesaid, on the 19th day of September, 1989, reported to said Court the

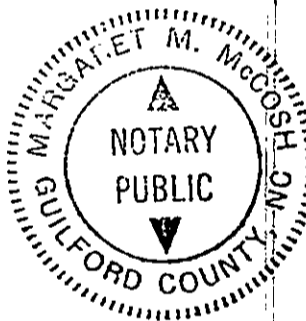
