TRACT II:

BEGINNING at an iron stake in the west line of Sink Street, 92.6 feet from the northwest corner of the intersection of Brookline and Sink Streets; thence with the west line of Sink Street 57.7 feet to an iron stake, and of the width of 57.7 feet extending westwardly between parallel lines 150 feet to a 15-foot alley, being the lot conveyed to the grantors herein by deed from R. T. Coe and wife, recorded in the office of the Register of Deeds of Forsyth County in Book 234 of Deeds at page 75. See also quitclaim deeds recorded in Book 242 at page 208 and 209. Being the same property conveyed to Humbert-Brantley by deed dated December 29, 1982.
