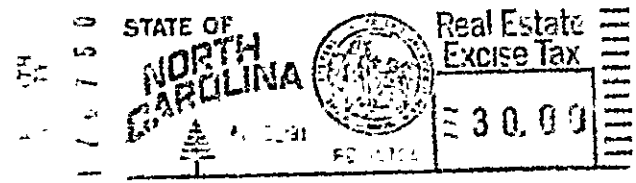

WITNESSETH, that the Grantor, in consideration of \$ 10.00 & OVC Ten Dollars and other valuable consideration to them paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the grantee in fee simple, all that certain lot or parcel of land in Forsyth County, North Carolina WINSTON Township, more particularly described as follows:

BEING located on South Main Street, and BEING KNOWN and designated as Lot No. 332, as shown on the map of Central Terrace, as recorded in Plat Book 3, Page 65 A in the Office of Register of Deeds of Forsyth County, North Carolina, to which map reference is hereby made for a more definite description; Being the same property as that described in Deed of Trust Book 863, page 72, same office as stated above.
