THIS DEED, Made this the 12th day of June, 1991 by R. FRANK MCNEIL, Executor, of the Estate of Obie W. McMichael, Grantor to BARBARA M. LUNSFORD, Grantee all of Forsyth County, North Carolina.

WITNESSETH

That OBIE W. MCMICHAEL, died testate in Forsyth County, North Carolina on July 11th, 1990, leaving a Last Will and Testament dated July 18th, 1989, that has been duly probated.

That OBIE W. MCMICHAEL by his will directed his Executor to convey certain real property to his devisees.

A family settlement agreement was recorded on April 5th, 1991, in Book 1712, Page 3658 of the Forsyth County Registry.

WHEREAS the said R. FRANK MCNEIL has caused the lands of OBIE W. MCMICHAEL to be surveyed and divided in accordance with the terms of his last will and the family settlement agreement.

NOW, THEREFORE, as directed by the last will of OBIE W. MCMICHAEL, R. FRANK MCNEIL, Executor, does by these presents, hereby sells and conveys to the said BARBARA M. LUNSFORD, and his successors, heirs and assigns, that certain parcel or tract of land, situated in Forsyth County, North Carolina, and described as follows:

BEGINNING at a point in the center of a 30 foot easement, said point being located North 33 deg. 59 min. 04 sec. West 360.00 feet and South 54 deg. 25 min. 38 sec. West 530 feet from a point marked by an iron in the North right of way line of U.S. Highway #158 that marks the Southwestern corner of the Eddie J. McMichael property as recorded in Deed Book 972, page 61 of the Forsyth County Registry; thence from said BEGINNING point with the center of said easement North 33 deg. 59 min. 04 sec. East 180.00 feet to a point marked by an iron; thence North 53 deg. 14 min. 50 sec. East 252.62 feet to a point marked by an iron; thence South 35 deg. 18 min. 22 sec. East 180.00 feet to a point marked by an iron; thence South 53 deg. 16 min. 53 sec. West 256.77 feet back to the point and place of BEGINNING and containing 1.05 acres more or less as per survey by Larry L. Callahan during November of 1990 and being Lot No. 18 of the O. W. McMichael Estate.

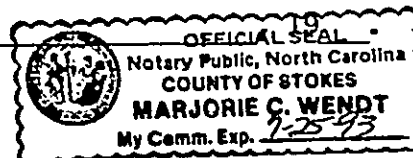
