**FORSYTH COUNTY, NORTH CAROLINA GENERAL WARRANTY DEED**

THIS DEED made this 9th day of November, 19 92, by and between

The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.  
WITNESSETH, that the Grantor, in consideration of (\$ 10.00 ) and other considerations to Katie O. Ingram paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the grantee in fee simple, all that certain lot or parcel of land in Forsyth County, North Carolina Township, more particularly described as follows:

BEGINNING at an iron stake in the West margin of Old Rural Hall Road, corner of Bryce H. Cox, et ux; running thence South 89° -32' -08" West 423.18 feet to an iron stake, corner of Carter B. Wallace, et ux; thence along the Wallace line North 19° -34' -42" West 209.68 feet to an iron stake, corner of W. V. May, et ux; thence along the May line North 89° -22' -40" East 423.43 feet to an old iron in the West margin of Old Rural Hall Road; thence along the West margin of Old Rural Hall Road South 19° -24' -37" East 210.70 feet to an iron stake containing 1.93 acres, more or less, and being known as Lot No. 201, Block 2367, Forsyth County Tax Map, and being that property conveyed to W.
