WITNESSETH, that the Grantor, in consideration of (\$ 10.00 & OVC) VALUABLE CONSIDERATIONS, has and by these presents does grant, bargain, sell and convey unto the grantee in fee simple, all that certain lot or parcel of land in Forsyth County, North Carolina, Winston Township, more particularly described as follows:

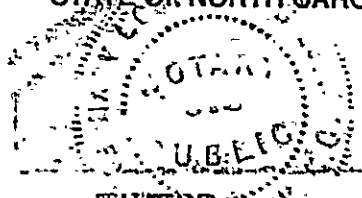
BEING INFORMALLY KNOWN AS Tax Lot 58, Block 3830, Winston Township, Forsyth County Tax Records.
