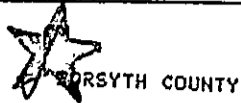

The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.  
WITNESSETH, that the Grantor, in consideration of (\$10.00 & O.V.C.) Ten Dollars and Other Consideration to Be paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the grantee in fee simple, all that certain lot or parcel of land in Forsyth County, North Carolina Winston Township, more particularly described as follows:

BEING KNOWN AND DESIGNATED AS LOT NO.8 AS SHOWN ON THE MAP OF RE-SUBDIVISION OF LOTS NOS. 18 THROUGH 26, PROPERTY OF LEWIS LONG AS RECORDED IN PLAT BOOK 18 PAGE 18 IN THE OFFICE OF THE REGISTER OF DEEDS OF FORSYTH COUNTY, NORTH CAROLINA REFERENCE TO WHICH IS HEREBY MADE FOR A MORE PARTICULAR DESCRIPTION. ALSO BEING KNOWN AND DESIGNATED AS BLOCK 1846, LOT 8B, FORSYTH COUNTY TAX MAPS.

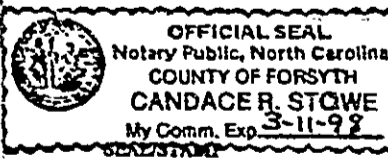
