WITNESSETH: That the Grantor, for and in consideration of the sum of \$1.00 & OVC (One and OVC) Dollars and other good and valuable considerations to him in hand paid by the Grantee, the receipt whereof is hereby acknowledged, has given, granted, bargained, sold and conveyed, and by these presents does give, grant, bargain, sell, convey and confirm unto the Grantee, his heirs and/or successors and assigns, premises in Middlefork Township, Forsyth County, North Carolina, described as follows:

BEGINNING at an iron stake in the East right of way line of the Baux Mountain Road, said iron stake being in the Southwest corner of Lot No. 29, Section 1 of Laurel Springs, Map of which is recorded in Plat Book 23, Page 33, in the Forsyth County Registry; running thence South 87 deg. 00 min. East 250.00 feet along the South line of said Lot No. 29, to an iron stake, a new corner; thence South 00 deg. 31 min. 53 sec. 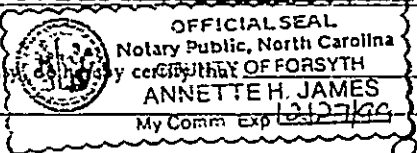
