## NORTH CAROLINA GENERAL WARRANTY DEED

THIS DEED made this 17th day of April , 19 96 , by and between

WITNESSETH, that the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land situated in the City of Kernersville , Kernersville Township, Forsyth County, North Carolina and more particularly described as follows:

BEING KNOWN AND DESIGNATED as Tracts 1, 2 and 3 of Kernersville Development Co., as shown on a map and plat of same which is recorded in Plat Book 11, Page 48, in the Office of the Register of Deeds of Forsyth County, North Carolina, reference to which is hereby made for a more particular description.

Save and except from Tract 3 the following:

Beginning at an iron stake which marks corner of Lot No. 152 on Adams St., running thence along line dividing Lot No. 152 and Tract No. 3 toward Reedy Creek Branch 175 ft. to an iron stake in said branch; thence 67 ft. down said branch to iron stake; thence back to starting point 169 ft.

Subject to easements, restrictions and rights of way of record, if any, and ad valorem taxes.

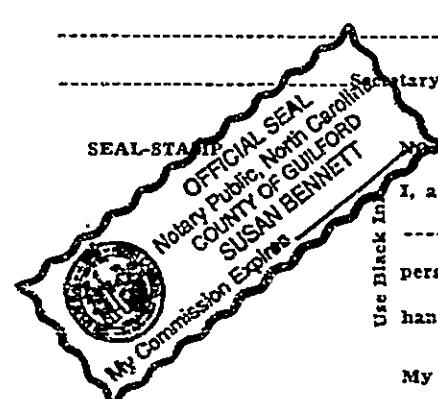
