THIS DEED, made and entered into this 18th day of October, 1996, by and between
RITE AID OF NORTH CAROLINA, INC., a North Carolina corporation, "GRANTOR", and
REVCO DISCOUNT DRUG CENTERS, INC., a Michigan corporation, "GRANTEE"; *Revco*

WITNESSETH:

That the said Grantor, in consideration of the sum of TEN DOLLARS (\$10.00) to it
paid by the Grantee, receipt of which is hereby acknowledged, has bargained and sold and
by these presents does bargain, sell and convey to the Grantee, and its successors and
assigns, a certain tract or parcel of land in Winston Township, Forsyth County, State of
North Carolina, described as follows:

BEGINNING at the Northwest corner of the intersection of Trade and Fourth Streets,
thence Northwardly along the western line of Trade Street 75 feet to an iron stake; thence
Westwardly along the southern face of the brick wall 90.95 feet to a point; thence
Southwardly in a line approximately at right angles to West Fourth Street 76.34 feet to a
cross cut in concrete in the northern line of West Fourth Street; thence with the northern
line of West Fourth Street Eastwardly 90.12 feet to the place of BEGINNING.

Reference is hereby made to a plat of the property of Masonic Temple Company dated
June 19, 1929, prepared by John D. Spinks, C.E., recorded in Plat Book 6, at page 173,
in the Office of the Register of Deeds of Forsyth County. The property described above
is all of the shaded area shown on said plat and, in addition, a part of the unshaded strip
lying immediately north thereof having a width on Trade Street of 9.93 feet and a width at
the western end of 11.16 feet and a length measured from the west side of Trade Street
westwardly of 90.95 feet.

The above described property is all of the property formerly owned by Trade & Fourth
Corporation at the northwest corner of Trade Street and West Fourth Street except a strip
fronting 9.97 feet on the north side of West Fourth Street and extending back
approximately 76.38 feet, conveyed by Trade & Fourth Corporation to Anna Ogburn by an
agreement and deed of conveyance dated January 14, 1946, recorded May 21, 1946, in
Deed Book 548, at page 274, in the Office of the Register of Deeds of Forsyth County,
North Carolina.

BEING the same property formerly owned by Wachovia Bank & Trust Company, N.A.,
Trustee for Walgreen Profit-Sharing Retirement Trust, formerly the Charles R. Walgreen
Memorial Pension Trust, and conveyed to Rite Aid of North Carolina, Inc., Grantor herein,
by deed dated July 31, 1972 and recorded July 31, 1972 in Deed Book 1036, at page 612,
in the Office of the Register of Deeds of Forsyth County, North Carolina.

Subject to covenants, conditions, restrictions, and encroachments, easements and
reservations, if any, in any former instruments of record, any state of facts an accurate
survey may show; existing leases and tenancies; and taxes for 1996 which have been
prorated to date of this conveyance.

TO HAVE AND TO HOLD the aforesaid tract or parcel of land and all privileges and
appurtenances thereunto belonging to the said party of the second part, its successors and
assigns.

And the said Rite Aid of North Carolina, Inc., does hereby covenant that it has not placed
or suffered to be placed any presently existing liens or encumbrances on said premises
and that it will warrant and defend the title to the same against the lawful claims of all
persons claiming by, through, under or on account of Rite Aid of North Carolina, Inc.


