THIS DEED made this the 3rd day of February, 1997 by and between B & B REALTY, a North Carolina General Partnership, hereinafter referred to as "Grantor" and SAM C. OGBURN REAL ESTATE COMPANY, INC., a North Carolina corporation, hereinafter referred to as "Grantee".

W I T N E S S E T H:

THAT the Grantor, in consideration of One Hundred and No/100 (\$100.00 & OVC) Dollars and Other Valuable Considerations to it paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land in Forsyth County, North Carolina in Winston Township, more particularly described as follows:

BEGINNING at an axle at the intersection of the southern right-of-way line of Sixteenth Street with the western right-of-way line of a 15-foot alley; thence along the western right-of-way line of said alley South 02° 26' 45" West 89.63 feet to an iron at the northeastern corner of the property of St. James A.M.E Church as described in deed recorded in Book 882 at Page 502, Forsyth County Registry; thence from said beginning point along north line of said Church property North 87° 30' 00" West 50.00 feet to an iron at the southeast corner of property of Henry F. Craver, Jr. as described in deed recorded in Book 1301 at Page 895, Forsyth County Registry; thence along Craver's east line North 02° 34' 00" East 90.00 feet to a rebar in the southern right-of-way line of Sixteenth Street; thence along the southern right-of-way line of Sixteenth Street South 87° 04' 44" East 49.81 feet to the point and place of BEGINNING and being identical property as described in deed recorded in Book 1583 at Page 1698, Forsyth County Registry, all according to survey of Larry L. Callahan dated January 30, 1997.

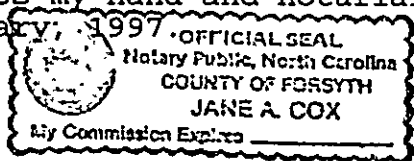
