The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.
WITNESSETH, that the Grantor, in consideration of (\$ 10.00 & O.V.C.) TEN DOLLARS & other good & valuable consideration Grantor paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the grantee in fee simple, all that certain lot or parcel of land in Forsyth County, North Carolina Salem Chapel Township, more particularly described as follows:

BEGINNING at an iron stake in the centerline of a 50-foot street (said street also being known as Ben Lane), said iron stake being located at the northwest corner of the Ronald L. Shrewsbury tract described in Deed Book 1499, Page 1772, Forsyth County Registry, thence from said beginning point South 28 deg. 38 min. 01 sec. West 384.64 feet to an iron stake; thence North 21 deg. 19 min. 16 sec. West 165.00 feet to an iron stake; thence North 36 deg. 08 min. 38 sec. East 313.74 feet to an iron stake in the centerline of said street; thence with the centerline of said street South 40 deg. 33 min. East 91.85 feet to an iron stake, the point and place of BEGINNING, all according to survey by Larry L. Callahan, R.L.S., entitled "Map for R. Don Cain" dated September 22, 1984, Job No. 1290-4.

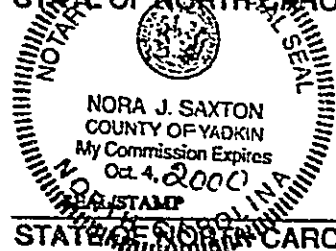
