WITNESSETH: That the Grantor, for and in consideration of the sum of (\$10.00 & 0.V.G.C.) Ten and 00/100 Dollars  
and other good and valuable considerations to him in hand paid by the Grantee, the receipt whereof is hereby acknowledged, has given, granted, bargained, sold  
and conveyed, and by these presents does give, grant, bargain, sell, convey and confirm unto the Grantee, his heirs and/or successors and assigns, premises in  
Salem Chapel Township, Forsyth County, North Carolina, described as follows:

BEGINNING at a point marked by an iron pin at the intersecting point of the  
eastern right of way line of Baux Mountain Road (S.R. 1946) and the northern  
right of way line of Lake Woussicket Road (S.R. 1940) said point is located  
North 59 deg. 55 min. 28 sec. East 50.61 feet from a point marked by a PK  
nail in the pavement of Baux Mountain Road (S.R. 1946) that marks the  
intersecting point of Lake Woussicket Road (S.R. 1940); thence from said  
point of BEGINNING North 18 deg. 31 min. 23 sec. East 84.88 feet to a point  
marked by an iron; thence North 15 deg. 31 min. 13 sec. East 126.83 feet to  
a point marked by an iron pin, (said point is located South 73 deg. 53 min.  
30 sec. West 1046.15 feet from a point marked by an iron that marks the  
southeastern corner of Kenneth R. Dixon, Deed Book 1892, Page 1486 of the  
Forsyth County Registry); thence South 85 deg. 27 min. 36 sec. East 183.29  
feet to a point marked by an iron; thence South 13 deg. 04 min. 58 sec. West  
219.05 feet to a point marked by an iron in the north right line of Lake  
Woussicket Road, (S.R. 1940) thence with the north right of way line of said  
road North 82 deg. 36 min. 15 sec. West 195.66 feet back to the point and

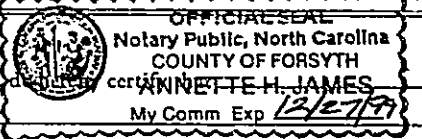
