That said Grantor, for and in consideration of the sum of Ten Dollars (\$10.00) to him in hand paid, the receipt of which is hereby acknowledged, has remised and released and by these presents does remise, release, convey, and forever quitclaim unto the Grantee, his heirs and/or successors and assigns, all right, title, claim and interest of the Grantor in and to a certain lot or parcel of land lying and being in

Winston Township, Forsyth County, North Carolina, and more particularly described as follows:

BEGINNING at a stake in the western line of Wilkes Drive (formerly Washington Drive), the northeast corner of Lot No. 12 on Map hereinafter referred to; thence with the northern line of Lot No. 12 in westerly direction 125 feet to the northwest corner of Lot No. 12; thence in a northerly direction 50 feet to a stake, the southwest corner of Lot No. 15, thence in an easterly direction with the southern line of Lot No. 15, 125 feet to a stake in the western line of Wilkes Drive (formerly Washington Drive), the southeast corner of Lot No. 15; thence in southerly direction with the western line of Wilkes Drive (formerly Washington Drive), 50 feet to the place of Beginning. Being known and designated as Lots Nos. 13 and 14, Block 3, Washington Park, Section 1, which is recorded in Plat Book 4, Page 185, in the Office of the Register of Deeds of Forsyth County, North Carolina, to which reference is hereby made for a more definite description.

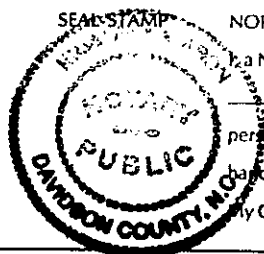

It is further intended and agreed that this conveyance is made pursuant to the provisions of NCGS 52-10 and NCGS 29-30(a)(2) to extinguish any claim by Grantor of any marital interest in the above described property, which shall henceforth be the sole and separate property of the Grantee, and to extinguish any present or future claims of the Grantor for equitable distribution which may arise under NCGS 50-20, et. seq.

To have and to hold the aforesaid lot or parcel of land and all privileges thereunto belonging to him, the Grantee, his heirs and/or successors and assigns, free and discharged from all right, title, claim or interest of the Grantor or anyone claiming by, through or under him.

The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.
