 WITNESSETH, that the Grantor, in consideration of \$ 10.00 and OTC, Ten Dollars & Other Valuable Considerations paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the grantee in fee simple, all that certain lot or parcel of land in Forsyth County, North Carolina, Middlefork Township, more particularly described as follows:

Beginning at an iron stake, said iron stake being the southwest corner of lot no. 78 and the southeast corner of lot no. 77 on the map of Silver Chalice, Section 3 as recorded in Plat Book 39, Page 179 in the Forsyth County Register of Deeds Office, Forsyth County, North Carolina; thence with the southern line of lot no. 78 N.64°00'20" E. 80.00' to an iron stake in the southeast corner of lot no. 78 and the southwest corner of lot no. 79 on the aforementioned map of Silver Chalice, Section 3; thence with the eastern line of lot no. 78 N.25°59'40"W. 20.00' to a new corner; thence along a new line S. 49°58'10"W. 82.46' to the place of beginning and containing 800 square feet more or less.
