FORSYTH COUNTY, NORTH CAROLINA GENERAL WARRANTY DEED

This Deed made this 2nd day of December, 1997, by and between the Grantor and the Grantee named below:

The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, feminine, masculine or neuter, person or entity as required by context.

WITNESSETH, that the Grantor, in consideration of \$10.00 and other valuable considerations, paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land situated in the Township of Clemmons, County of Forsyth, State of North Carolina and more particularly described as follows:

BEGINNING at an iron stake in the eastern right-of-way line of Fleetwood Circle, said iron stake being located at the southwest corner of the Carlos D. Folds property described in Deed Book 1359 at Page 244, Forsyth County Registry and the northwest corner of the within described tract, thence from said BEGINNING point South 74° 35' East 108.79 feet to an iron stake; thence North 15° 04' East 23.60 feet to an iron stake; thence South 87° 13' East 212.20 feet to an iron stake; thence South 26° 32' West 190.10 feet to an iron stake; thence North 72° 56' 43" West 300.39 feet to an iron stake within the right-of-way of Fleetwood Circle; thence North 26° 32' East 110.00 feet to an iron stake, the point and place of BEGINNING, being 0.989 acres, more or less, in according to a survey by Larry L. Callahan, RLS entitle "Map of John C. Duren, Sr." dated December 15, 1982, Job No. 1351-1.

THE PURPOSE OF THIS INSTRUMENT IS TO TERMINATE TENANCY BY THE ENTIRETY AND CONVEY FULL TITLE TO THE GRANTEE.
