FORSYTH COUNTY, NORTH CAROLINA GENERAL WARRANTY DEED

THIS DEED made this 8th day of June, 19 98, by and between

The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.
WITNESSETH, that the Grantor, in consideration of \$ 10.00 & OVC (Ten dollars and other valuable consideration) to her paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the grantee in fee simple, all that certain lot or parcel of land in Forsyth County, North Carolina, Middlefork Township, more particularly described as follows:

Situate on the west side of Chandler Street in Motor Heights No. 2 in the City View Section three miles east of Winston-Salem, N.C., beginning at a stake on the west side of Chandler Street the S.W. corner of Raymond Fulp's Lot No. 23, thence in a westwardly direction along Chandler Street 150 feet to a stake in R. Lee Angel's line, thence northwardly along said Angel's line 170 feet to a stake, thence south 65 degrees 21' east 239 feet to a stake in the N.E. corner of Lot No. 23 owned by Raymond Fulp, thence along the line of Lot No. 23, 144 feet to the place of beginning.

For a more particular description reference is made to Lots No. 20, 21, and 22 which are recorded in the Office of the Register of Deeds for Forsyth County, N.C. in Plat Book No. 3, Page 73a.

**The previous Deed (book 1637, page 3729) was conveyed to Barbara F. Wolfe under a Power of Attorney granted to her by her mother. The Power of Attorney (book 1335, page 1266) did not contain the authority to make gifts of property without consideration. However, this situation was corrected by the estate proceedings of Cleatie C. Fulp, see Forsyth County estate file 1998 E0-31.

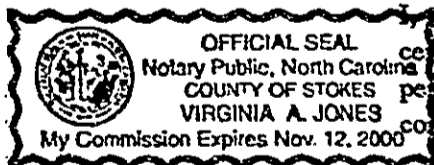
The above land was conveyed to Grantor by Cleatie C. Fulp (see book number 1637 page 3729)
