W I T N E S S E T H:

WHEREAS, WILLIAM A. STARBUCK was duly appointed as
Trustee under Agreement dated July 1, 1980 with KATHRYN GAYER
STARBUCK ROMINGER; Trustee under Agreement dated July 1, 1980 with
RICHARD STARBUCK; Trustee under Agreement dated July 1, 1980 with
WILLIAM AGURS STARBUCK, JR.; Trustee under Agreement dated July 1,
1980 with HENRY CONRAD STARBUCK; and Trustee under Agreement dated
July 1, 1980 with NANCY LEE STARBUCK.

WHEREAS, WILLIAM A. STARBUCK has continuously acted in
his capacity as Trustee under the Agreements as set forth herein
since July 1, 1980 and is presently acting in said capacity under
each of those Agreements; and

WHEREAS, WILLIAM A. STARBUCK, as Trustee, holds a 1/5
undivided interest in the real property herein below described
under each of the said Agreements; and

WHEREAS, each of the said Agreements authorizes the
Trustee to sell, assign and otherwise deal with properties held by
the Trustee;

NOW, THEREFORE, the Party of the First Part, acting in
his capacity as Trustee under the said Agreements dated July 1,
1980 in consideration of one dollar and other valuable
consideration (\$1.00 and OVC) to him paid by the Party of the
Second Part, the receipt of which is hereby acknowledged does
hereby grant, bargain, sell, convey and transfer to the said Party
of the Second Part and its successors and Assigns, in fee simple
the following described real estate tracts located in Forsyth
County, North Carolina.

First Tract:

BEGINNING at the northwest corner of Liberty and Sixth Streets and running thence northwardly along Liberty Street fifty (50) feet thence westwardly and parallel with Sixth Street one hundred and four (104) feet to a ten-foot alley thence southwardly along said alley fifty (50) feet to Sixth Street; thence eastwardly along Sixth Street one hundred and four (104) feet to the point of BEGINNING.

The above-described lot of land was conveyed to W. O. Crotts by J. Cicero Tise and wife, Laura E. Tise. See Deed recorded in Book 94, Page 560, Office of the Register of Deeds of Forsyth County. 
