and the Commissioner was licensed by said order to sell land hereinafter described at PUBLIC sale, after due advertisement according to law and;

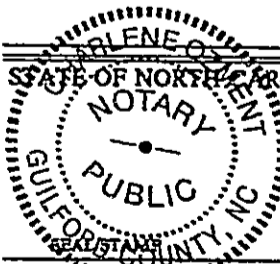
