

### NORTH CAROLINA GENERAL WARRANTY DEED

THIS DEED made this 3rd day of November, 1999, by and between

WITNESSETH, that the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land situated in the City of Winston-Salem, Winston Township, Forsyth County, North Carolina and more particularly described as follows:

BEGINNING at a point on the south side of Dixie Broadway Street 483.5 feet west of the southwest intersection of Dixie Broadway and Vargarve Street, and running thence in a southwardly direction 133.7 feet to an iron stake; thence in a westwardly direction 40 feet to an iron stake; thence in a northwardly direction 133 feet to an iron stake in the south side of Dixie Broadway Street, thence in an eastwardly direction 40 feet along the south side of Dixie Broadway Street to the place of BEGINNING. Being known and designated as Lot 18 on the plat of Dixie Heights which is recorded in Plat Book 3, at page 17, Office of the Register of Deeds of Forsyth County, North Carolina, to which reference is hereby made.

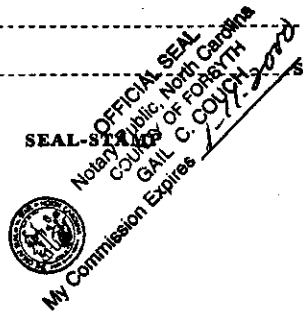
