BEING KNOWN AND DESIGNATED AS lots 39, 40, 41, and 42, as shown on the map of Southdale, recorded in Plat Book 3, at Page 71, in the Office of the Register of Deeds of Forsyth County, North Carolina, reference to which map is hereby made for a more particular description.

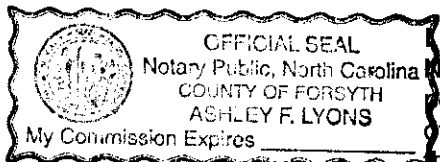
