The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.

WITNESSETH, that the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land situated in the City of Abbotts Creek Township, Forsyth County, North Carolina and more particularly described as follows:

Any lot herein conveyed which is a part of The Authors shall be subject to the Plan of Development as the same is recorded in Book 1839 at Page 3416, in the Office of the Register of Deeds of Forsyth County, North Carolina, and any amendments thereto.

By acceptance and recordation of this Deed, as the same relates to the Lot which is herein conveyed and is a part of The Authors, the Grantee and each of them acknowledge that the Lot above described is conveyed subject to the aforesaid Plan of Development and that the Grantee and each of them shall be obligated to become and remain a member of The Authors Homeowners Association so long as the Grantee and each of them shall own the above described Lot or any lot in The Authors; that the Grantee and each of them shall be obligated to pay such dues, assessments and other sums as may be imposed from time to time pursuant to the terms of the Plan of Development as referred to above.
