That said Grantor, for and in consideration of the sum of Ten Dollars (\$10.00) to him in hand paid, the receipt of which is hereby acknowledged, has remised and released and by these presents does remise, release, convey, and forever quitclaim unto the Grantee, his heirs and/or successors and assigns, all right, title, claim and interest of the Grantor in and to a certain lot or parcel of land lying and being in

BEGINNING at an iron stake in the southern right of way of Kyle Road, the northeast corner of Lot 12 and the northwest corner of Lot 13 on the Map hereinafter described; thence running south 86 deg. 30 min. west 195 feet to an iron stake; thence north 86 deg. 17 min. west 45 feet to an iron stake; thence north 3 deg. 43 min. east 200 feet to an iron stake in the southern right of way line of Kyle Road; thence with said right of way line south 86 deg. 17 min. east 37 feet to a point; thence continuing with said right of way line on a curve to the right, a chord distance and direction of 88 feet and south 89 deg. 49 min. east to the point and place of beginning and being the east portion of Lot 12, Map of Noah A. Brewer Property, recorded in Plat Book 17 at Page 142, in the Forsyth County Registry, North Carolina, also being Lot 12-B, Block 3966, Forsyth County Tax Map.

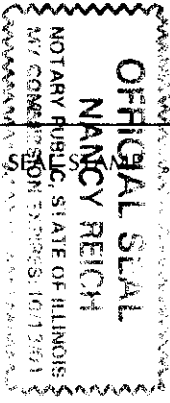


