Save and except easements, rights of way and restrictions of record, if any.

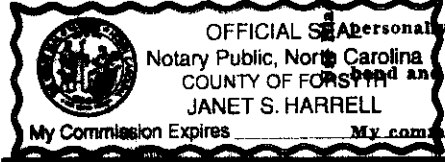
