2001 ad valorem taxes.

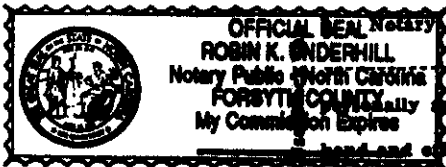
