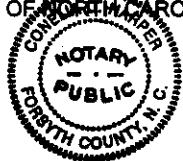

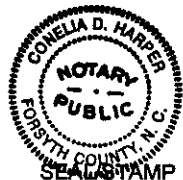

BEGINNING at a ½ inch established iron pipe being located in the northeastern corner of the Grantors' property as recorded in Forsyth County Registry Deed Book 2009, page 86, said established iron pipe further being in the southern margin of a 100-foot right of way of Southern Railroad, also being in the northwestern corner of that property owned by Amp, Inc., as recorded in Forsyth County Registry Deed Book 1119, at Page 540; thence from said Beginning established iron pipe and running South 27 degrees 32' 50" East 540.61 feet to an existing railroad spike in the northern right of way of Myer Lee Drive; thence with the northern right of way of Myer Lee Drive South 63 degrees 32' West 160.47 feet to a ¼ inch iron pipe; thence North 21 degrees 20' 10" West 109.69 feet to a ¼ inch iron pipe; thence North 67 degrees 36' 12" East 47.63 feet to a ¼ inch iron pipe; thence North 23 degrees 51' 23" West 435.44 feet to a ¼ inch iron pipe in the southern margin of a 100-foot right of way of Southern Railroad; thence with the southern margin of said right of way of Southern Railroad North 63 degrees 48' 06" East 73.13 feet to a ½ inch established iron pipe, the point and place of Beginning.
