WITNESSETH, that the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, that certain lot or parcel of land situated in the City of Winston-Salem Township, Forsyth County, North Carolina and more particularly described as follows:

East 100.00 feet to a new 1/2-inch iron pipe in the northwest corner of the property of Monte E. Burns (see Deed recorded in Book 1626, Page 4351, Forsyth County Registry, also being the northwest corner of the property designated as Lot 24-A in Tax Block 1647 as shown on the Forsyth County Tax Maps, as presently constituted), now or formerly; thence with the western boundary line of the aforesaid Monte E. Burns property, South 03 deg. 38 min. 17 sec. East 220.00 feet to a new 1/2-inch iron pipe in the northeast corner of the property of George G. Shore (see Deed recorded in Book 852, Page 50, Forsyth County Registry), now or formerly; thence with the northern boundary line of the aforesaid George G. Shore property, South 86 deg. 01 min. 46 sec. West 100.00 feet to a new 1/2-inch iron pipe in the northwest corner of the said George G. Shore property; thence with the eastern boundary line of the aforesaid Winston-Salem/Forsyth County Board of Education property, North 03 deg. 38 min. 17 sec. West 220.00 feet TO THE POINT AND PLACE OF BEGINNING, containing approximately 0.50 acres as shown on unrecorded survey dated March 8, 2002, prepared by Joseph E. Franklin, R.L.S. (Job No. 18-271), reference to which is hereby made for a more particular description and which survey is incorporated herein by this reference; the said property being the northern portion of Lots 25 & 26 of Motorville, Section 1, recorded in Plat Book 3, Page 82 A, and being all of the property described in Deed recorded in Book 2196, Page 1233, Forsyth County Registry.
