2. **Any and all restrictive covenants, easements and rights-of-way of record, if any.**

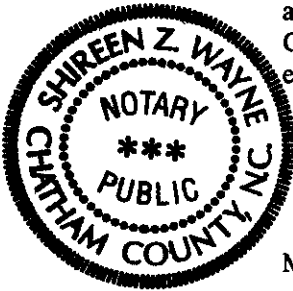
