GENERAL WARRANTY DEED

This Deed made this the 12th day of May, 2003 by and between
 MARY N. MARTIN (WIDOW); WILLIAM JUNIOR NELSON AND WIFE, LOUELLA
 NELSON; AND ALBERT NELSON AND WIFE, MARGORIE NELSON, HEIRS OF
 VIRGINIA C. NELSON, parties of the first part, to CECIL OLIVER,
 party of the second part:

W I T N E S S E T H:

THAT the said parties of the first part, for and in
 consideration of the sum of TEN DOLLARS AND OTHER VALUABLE
 CONSIDERATION (\$10.00 O.V.C) to them paid by the said party of the
 second part, the receipt of which is hereby acknowledged, have
 bargained and sold, and by these presents do bargain, sell and
 convey unto the said parties of the second part and this their
 heirs a tract of land being in Forsyth County, North Carolina, and
 described as follows:

BEGINNING at a stake in the west side of Whitfield Street,
 said stake being 180 feet North of the Northwest intersection of
 Whitfield Street with White Street and running thence South 2
 degrees 37 minutes West 60 feet to a stake the Northeast corner of
 lot #53; thence North 87 degrees 23 minutes West, with the North
 line of Lot #53 a distance of 150 feet to a stake, the Northwest
 corner of Lot #53 thence running North 2 degrees 37 minutes East 60
 feet to a stake; thence running South 87 degrees 23 minutes East
 150 feet to a stake the point of beginning.

TO HAVE AND TO HOLD the aforesaid lot or parcel of land and
 all privileges and appurtenances thereto belonging to the Grantors in

fee simple.

And the Grantors covenant with the Grantee, that Grantors are seized of the premises in fee simple, have the right to convey the same in fee simple, that title is marketable and free and clear of all encumbrances, and that Grantors will warrant and defend the title against the lawful claims of all persons whomsoever except for the exceptions hereinafter stated. Save and except easements and restrictions of record if any.

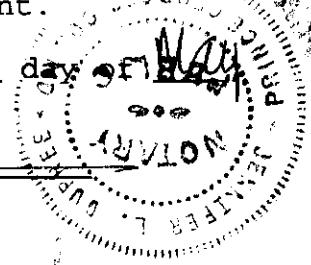
