## GENERAL WARRANTY DEED

FORSYTH COUNTY

THIS DEED made this 6th day of July, 2004, by and between CAROL K. VEST, widow of EDWARD G. VEST, hereinafter referred to as "Grantor"; and FRANK GARRETT, hereinafter referred to as "Grantee";

## WITNESSETH:

That the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land situated in Middlefork Township, Forsyth County, North Carolina and more particularly described as follows:

Being known and designated as Lot 23 as shown on the map of GLADSTONE COURTS, said may being recorded in Book 17, page 183, in the office of the Register of Deeds for Forsyth County, North Carolina, to which reference is hereby made for a more particular description.

Reference is hereby made to Book 725, page 222, Forsyth County Registry.

Subject property was conveyed in April, 1956, to Homer D. Cooke and wife, Mary D. Cook, parents of Edward G. Vest by General Warranty Deed recorded in Book 725, page 222, Forsyth County Registry. That Mary Cooke was preceded in death by her husband, Homer Cooke. That Mary Cooke, mother of Edward G. Vest, died in the early 1980's. That Edward G. Vest died January 8, 2004, with his spouse surviving, Carol K. Vest, Grantor herein.

TO HAVE AND TO HOLD the aforesaid lot or parcel of land and all privileges and appurtenances thereto belonging to the Grantee in fee simple.

And the Grantor covenants with the Grantee, that Grantor is seized of the premises in fee simple, has the right to convey the same in fee simple, that title is marketable and free and clear of all encumbrances, and that Grantor will warrant and defend the title against the lawful claims of all persons whomsoever except for the exceptions hereinafter stated. Title to the property hereinabove described is subject to the following exceptions:

Save and except easements, restrictions and right-of-ways of record, if any.

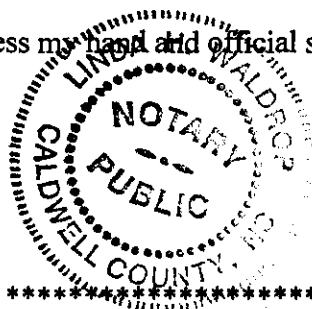
