STATE OF NORTH CAROLINA COUNTY OF FORSYTH

THIS INDENTURE Made this day of April, 2005, between Secretary of Veterans Affairs, an Officer of the United States of America, whose address is Department of Veterans Affairs, Washington DC 20420, hereinafter GRANTOR, and Charles D. Chenault Jr. and Debra B. Chenault, hereafter GRANTEE. The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural masculine, feminine or neuter as required by context.

WITNESSETH, that the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land situated in Forsyth County, North Carolina and more particularly described as follows:

Beginning at an iron stake in the southern right of way line of Sprague Street, said iron stake being the common corner of Lots 4 & 5 as shown on the Plat of Wachovia Development Company, Block 4, recorded in Plat Book 8, page 81, Forsyth County Registry; thence from said point of beginning and with the southern right of way line of Sprague Street South 87 degrees 14 minutes 10 seconds East 74.99 feet to a P.K. nail in the northwest corner of Harold W. Casey, Jr. and wife; thence with Casey's western line, South 03 degrees 4 minutes 50 seconds West 150.43 feet to an iron stake in the northern right of way line of a 15 foot unopened alley; thence North 86 degrees 50 minutes 26 seconds West 74.78 feet to an iron stake, the southeastern corner of Lot 4 as shown on the above referenced plat; thence with the common line of Lots 4 & 5, North 3 degrees 0 minutes 0 seconds East 149.91 feet to an iron stake in the southern right of way line of Sprague Street the point and place of beginning. Being all of Lot 5 and a western portion of Lot 6 as shown on the Plat of Wachovia Development Company, Block 4, as recorded in Plat Book 8, Page 81(2), in the Office of the Register of Deeds of Forsyth County, North Carolina, being Tax Lots 5 & 6A in Block 736 as presently shown on the Forsyth County Tax Maps, Said description in accordance with a survey made by William Franklin Tatum, RLS dated March 19, 1998 bearing job #S-8324.
