DEED

THIS DEED, made and entered into this 15 day of June, 2005, by and between **PILOT MOUNTAIN BAPTIST ASSOCIATION, A North Carolina Non-Profit Corporation**, hereinafter called "Grantors", and **MARK GODFREY and wife, ANGELA GODFREY**, hereinafter called "Grantees".

WITNESSETH:

That said Grantor, for and in consideration of the sum of Ten Dollars (\$10.00), and other good and valuable consideration, to it in hand paid, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey, unto the Grantees, their heirs, successors and assigns, all that certain lot or parcel of land lying and being in Forsyth County, North Carolina, and more particularly described as follows:

Bounded on the South by Monmouth Street on the East by a Lot now owned by J.C. Spach, on the North by Waughtown Street, and on the West by J.E. Beaman and Swaim Brothers; Said Lot fronting 50 feet on the North side of Monmouth Street and of that width runs Northwardly at right angles to Waughtown Street and is known on the plat of Wachovia Development Company as Lot #3 in Block #1, and is located in South Side in the vicinity of the intersection of Waughtown Street and Lexington Road. See Plat recorded in Plat Book 8, Page 81 (2).

A life estate in this property was devised to E.N. Hine, Jr. and wife, Annie Mae Reid Hine by E.N. Hine, Sr.. E.N. Hine, Sr., deceased in Forsyth County on May 7, 1957. E.N. Hine, Jr. deceased on September 21, 1969 in Forsyth County. Annie Mae Reid Hine deceased April 23, 2005 in Forsyth County. The Grantor herein is the remainderman under the Will of E.N. Hine, Sr.

To have and to hold the aforesaid lot or parcel of land and all privileges thereunto belonging to them, the Grantees, their successors and assigns, in fee simple, free and discharged from all right, title, claim or interest of the Grantor or anyone claiming by, through or under it.

And the Grantor covenants with the Grantees, that Grantor is seized of the premises in fee simple, has the right to convey the same in fee simple, that title is marketable and free and clear of all encumbrances, and that Grantor will warrant and defend the title against the lawful claims of all persons whomsoever except for the exceptions hereinafter stated. Title to the property hereinabove described is subject to the following exceptions: conditions, easements and restrictions of record, if any, and 2005 property taxes which will be prorated for the current tax year.

The designation "Grantor" and "Grantees", as used herein, shall include said parties, his heirs, successors, and assigns, and shall include singular, plural, masculine, feminine, or neuter as required by context.

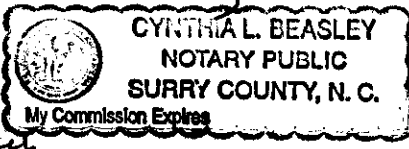
