THIS DEED, made October 18, 2005 by and between Elizabeth B. Ells, Substitute Trustee per document recorded in book 2590 page 882 Forsyth County Registry, for Hutchens & Senter, Trustee, in the deed of trust hereinafter mentioned, of Forsyth County, North Carolina, hereinafter referred to as "first party"; and Wells Fargo Bank Minnesota, N.A. as Trustee for Delta Funding Home Equity Loan Asset-Backed Certificates Series 2001-2, hereinafter, whether one or more, referred to as "second party" (the singular masculine pronoun wherever hereinafter used to be construed as masculine, feminine or neuter and as singular or plural as the context may indicate or require),

WHEREAS, under and by virtue of the authority contained in the certain Substitution of Trustee, as referenced herein, and filed with the Clerk of Forsyth County, North Carolina, the first party assigns said bid to Wells Fargo Bank Minnesota, N.A. as Trustee for Delta Funding Home Equity Loan Asset-Backed Certificates Series 2001-2.


