Restrictions and easements of record, if any.

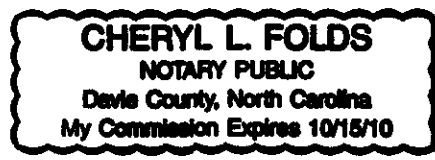

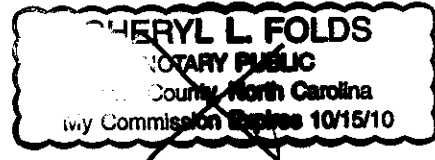
