The designation Grantee and Grantor as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.

Witnesseth, that the Grantor, in consideration of ( \$1.00 ) and other considerations to Carmelene L. Woods said paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in the fee simple, all that certain lot or parcel of land in Forsyth County, North Carolina Township, more particularly described as follows:

BEGINNING at an iron stake in the West margin of Old Rural Road, corner of Bryce H. Cox, et ux; running thence South 89 degrees -32' -08" West 423.18 feet to an iron stake, corner of Carter B. Wallace, et ux; line North 19 degrees -34' -42" West 209.68 feet to an iron stake, corner of W. V. May et ux; thence along the May line North 89 degrees -22' -40" East 423.43 feet to an old iron in the West margin of Old Rural Hall Road; thence along the West margin of Old Rural Hall Road South 19degrees -24' -37" East 210.70 feet to an iron stake containing 1.96 acres, more or less, and being known as Lot 201, Block 2367, Forsyth County Tax Map, and being that property conveyed to W.
