And the said Grantor does covenant that it is seized of said premises in fee and has the right to convey the same in fee simple; that the same are free from encumbrances; and that it will warrant and defend the said title to the same against the claims of all persons whatsoever. Subject to easements and restrictions of record, if any, and to 2006 ad valorem property taxes which will be pro-rated to the date of closing.

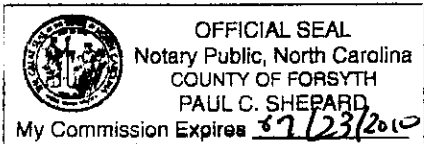


EXHIBIT A

BEGINNING at an existing rebar on the western edge of the Liberty Street right of way, the northeast corner of the Donna Gilmore lot recorded in Book 2086, Page 816 of the Forsyth County Registry (Tax Lot 114 of Tax Block 0277), thence along the northern edge of said lot 89 degrees, 50 minutes, 07 seconds west 204.59 feet to an iron rebar set, the northwest corner of said Donna Gilmore lot; thence north 00 degrees, 34 minutes, 52 seconds east 56.25 feet to an existing iron rebar, the northwest corner of the herein described lot; thence south 89 degrees, 45 minutes, 15 seconds east 44.35 feet to an existing iron pin; thence continuing in an easterly direction south 89 degrees, 51 minutes, 39 seconds east 160.34 feet to an existing iron pin on the western edge of the Liberty Street right of way; thence along the said western edge of the said Liberty Street right of way south 00 degrees, 41 minutes, 08 seconds west 56.26 feet to the POINT AND PLACE OF BEGINNING.
